## BUILD CWA POLITICAL POWER: SIGN UP FOR PAF TODAY!

Political power and influence helps us win for GSEU-CWA members.

- In 2019 we helped get the bill to ban mandatory fees for graduate workers passed unanimously in the New York State Senate.
- We've fought for Safe Staffing ratios in healthcare centers and in 2019 the New York State Legislature agreed to study the effects of healthcare worker staffing ratios, with dozens of CWA members testifying before the New York State Department of Health.
- Bernie Sanders and Hillary Clinton both walked the CWA picket lines in 2016, and Bernie denounced VZ CEO Lowell McAdam's "corporate greed" during the nationally televised primary debate.
- 100 Senators and Congressmembers signed a letter to the CEO of American Airlines in support of 5,000 CWA members at Envoy.
